NWPC will work to assess and evaluate three diverse population centers and their individual criminal justice responses to witness intimidation; and will initiate an individual pilot project in each jurisdiction to refine existing working responses and close gaps in neglected areas with specialized technical assistance, training, protocol development and evidence based national best practices.





Shooter lured officers with 911 call

Deadly attack

Three officers were killed and two wounded Tuesday night in a gunbattle with a man near Pleasanton.

- 1** Man calls police from mobile home. He then crosses street and hides behind barbed-wire fence and bushes.
- 2** Thomas Monse is the first sheriff's deputy on the scene. Monse is shot and killed as he steps out of his car.
- 3** Sheriff's Deputy Mark Stephenson arrives and is immediately shot and killed. Man approaches both officers' bodies and shoots them in the head.
- 4** DPS Trooper Terry Miller arrives and is shot and killed at the entrance of the driveway while still in his car. The car rolls backward and comes to rest at the curb.
- 5** Carl Fisher, a retired INS agent, pulls up to help and is shot and wounded before leaving his car.
- 6** Luis Tudyk, a Pleasanton police officer, arrives and is shot and wounded.
- 7** During a gunbattle with officers, man turns gun on himself.





The three law officers killed in the ambush:

■ Texas Department of Public Safety Trooper Terry Wayne Miller, 37, graduated from the DPS Academy in July 1997 and was stationed at the highway patrol office in Freer. He transferred to Pleasanton in September 1998. He was the 74th trooper killed in the line of duty.

Miller was born in Mercedes and graduated from Gregory-Portland High School. He became a police officer in Sinton in 1987 and worked as a San Patricio County sheriff's deputy from 1989 until joining the DPS. Miller is survived by his wife and two daughters, ages 22 months and 13.

■ Atascosa County Sheriff's Deputy Mark Stephenson, 32,

graduated from high school in Okinawa, Japan, and served in the military before becoming a police officer in the Bexar County town of Elmendorf.

Stephenson was a deputy for five years. He is survived by a wife and three children.

■ Atascosa County Sheriff's Deputy Thomas Monse, 31, a graduate of Pleasanton High School, worked for the department for two years.

Monse worked as a Bexar County deputy before working in Atascosa. He is survived by a wife and four children.

Atascosa County Sheriff Tommy Williams said Monse and Stephenson were dedicated lawmen. "Day or night, they were ready to go to work, 24 hours, anytime."

Officers shot in Randolph County standoff

29-year-old suspect arrested after 13 hours

MONTROSE — A 29-year-old man who allegedly shot four police officers in Randolph County was arrested Tuesday morning, ending a 13-hour standoff with dozens of police officers.

Scott Ennis was arrested about 8 a.m. by a special State Police team, four hours after they fired tear gas into the two-story residence in Montrose.

During the standoff, Ennis exchanged hundreds of gunshots with police, Randolph County Prosecuting Attorney Earl Maxwell said Tuesday.

"To my absolute amazement, given the fireworks I saw and the damage to the scene, they arrested him basically unhurt," Maxwell said.

He said Ennis suffered a bloody nose and was taken to Davis Memorial Hospital in Elkins. Ennis was in stable condition there, a spokeswoman said.

Troopers were assigned to

guard his hospital room. "He's going to be kept overnight," said State Police Capt. Chuck Jackson of the Elkins detachment. "We don't want to do this again."

Police hope to formally charge Ennis in court today, he said.

Three of the officers wounded in the shootout were also in stable condition at the hospital. The fourth was treated at the scene and remained on duty.

Ennis also allegedly wounded a fifth officer early Sunday, while escaping pursuing police officers in neighboring Upshur County. Buckhannon Cpl. Keith Rowan was struck in the face with fragments from bullets and glass. He was treated and released at a Buckhannon hospital.

That shooting caused officers to search for Ennis' vehicle. Police in a helicopter spotted a white pickup truck matching the description of the vehicle involved in Sunday's shooting at the Montrose residence.

That's when the standoff began Monday evening, after about

10 police officers went to the farmhouse to serve search and domestic battery warrants. The search warrant stemmed from Ennis' alleged involvement in Sunday's shooting of Rowan, Jackson said.

"[Ennis] opened up on them," Jackson said. He allegedly shot one officer then, and the others were injured during the ensuing exchange.

Ennis used a "high-powered rifle," along with several .22-caliber weapons and possibly others, Jackson said.

"He had numerous weapons, it's fair to say," Jackson said.

Randolph County Chief Deputy John Channell was wounded and lying in the line of fire, when a Randolph County deputy and trooper commandeered a fire truck and rescued him.

The two officers used the truck as a shield, parking it between the house and Channell. That allowed them to safely re-

Two Oklahoma deputies shot and killed

SEMINOLE, Okla. — A man opened fire on two sheriff's deputies trying to serve a domestic abuse warrant Sunday in Oklahoma, killing both officers and wounding a woman who was passing by, state investigators said.

Ezekiel Holbert, 26, was being held on first-degree murder charges in the deaths of the two Seminole County deputies.

The deputies were trying to serve an arrest warrant issued earlier this year for domestic assault and battery by strangulation

"As far as I know, she was totally unrelated to the case," Brown said.

The sheriff's office declined comment late Sunday, referring questions to the SBI. Brown said it wasn't clear whether Holbert had an attorney or when he would appear in court.

Holbert's mother called the sheriff's office around 3 p.m. after finding her son in her house in Seminole. She said he wasn't welcome.

When deputies knocked on the door, Holbert started shooting, Brown said. The deputies were trying to serve an arrest warrant issued earlier this year for domestic assault and battery by strangulation, though it wasn't immediately clear Sunday who Holbert was accused of assaulting.

Several law enforcement agencies responded to the shootings, evacuated the area and asked local businesses to shut down as they searched for the shooting suspect.

By about 7 p.m., the Oklahoma Highway Patrol used a robot with an audio speaker to approach the house.

"Through a PA system on that robot, tactical units announced their presence and required the suspect to come out and surrender," patrol Lt. George Brown told The Oklahoman newspaper. "The suspect did come out of the front of the residence and did surrender without further incident."





Parents killed during custody exchange

MIRACLE, Ky. (AP) — Two days after receiving full custody of her 7-year-old daughter and moments before Donna Sue Newcomer would have held the daughter in her arms, the child's father fatally shot her and was then killed by police.

Newcomer, 28, of Warsaw, Ind., and her husband, Edward Ernest Newcomer, were waiting to pick up the child Wednesday at the Creekside Market on Kentucky 987 near the Bell County community of Cubbage with two sheriff's officers, police said.


Newcomer had received court papers Monday granting her full custody of the child, according to a Kosciusko County, Ind., circuit court order.

The girl's father, Larry Johnson, 33, of Cubbage, arrived at the store about 10:30 a.m. CDT with the child. Cubbage is about 30 miles east of Middlesboro near the Kentucky, Virginia and Tennessee state lines.

A Kentucky State Police spokesman, Buddy Simpson, said Johnson fired a shot at Newcomer as she was approaching his pickup truck. After a warning from Bell County deputies not to shoot any more, Johnson fired another shot. The second shot, apparently fired by Johnson, struck and killed Newcomer, Simpson said. Deputies then returned fire, fatally wounding Johnson, Simpson said.

Newcomer and Johnson were pronounced dead at the scene, police said.

"They've had a lot of problems since their divorce," said Edward Earl Newcomer, the grandfa-

Man ambushes wife as she walks to hearing on abuse

She sought court help after his death threat

Luis Romero threatened to kill his wife a week ago after she moved out of their Northeast Baltimore apartment, vowing she would not live another day.


Alarmed, Rhonda Romero turned to the courts for help. Yesterday morning, 15 minutes before she was to have seen a judge, she was dead — shot in the head, po-

lice said, by her husband, one block from the courthouse on the steps of the War Memorial Building.

He then put the gun to his head and took his own life.

The gunfire occurred about 9:15 a.m. as hundreds of people were on their way to work or to do business in nearby government offices. Dozens witnessed the double shooting on North Gay Street across the plaza from City Hall.

One man watched the shooting from his second-floor office as he chatted with a friend on the telephone; another witness was heading [See Shoot, 6A]






Children's Safety Checklist

- Above all, remember to tell them "it is not your fault"


